

Summer Camp 2010

Registration Information and Application

To register for summer camp:

1. Turn in your completed registration form and \$50.00 deposit.
(Please note that the deposit is non-refundable and is required to reserve your space.)
2. Pay the remaining camp fees at least two weeks before your session begins.

<u>Teen Camp</u> Individual - \$199 Group - \$189 Early Bird Group - \$179
All Day High and Low Ropes Course \$30 Extra Transportation and lunch included

All rates include full room and board plus a camp T-shirt. A snack bar will be available. It is recommended that campers bring an additional \$15-\$25 to camp to purchase snacks and souvenirs.

Deposit Policy	All rates shown include a deposit of \$50, which is non-refundable, but is transferable boy for boy and girl for girl the same camp session. Spaces will not be held without a deposit.
Group Discount	In order to qualify for the Group Discount, there must be 10 or more campers on the initial registration. Please note the group leader information on our website.
Early Bird Discount	To qualify for the Early Bird Discount, there must be 10 or more campers on the initial registration and all forms must be postmarked or received by our office by April 30 th .
Age Requirement	Children must be 6 through 12 years old to be eligible for kids' camp. Teen camp is for teens ages 13-18.
Arrival & Departure	Campers should plan to arrive between 5:00 and 6:00 p.m. on the start date of their session. Check-out time is between 10:00 and 11:00 a.m. on the last day of each session.

Cancellations and Refunds

If the total camp fees due are not received at least two weeks prior to the camp session, the reservation will be considered cancelled with no refund. Group and individual cancellations must be received in our office no later than four weeks prior to the camp session in order to receive a refund of the full camp fee less the \$50.00 non-refundable deposit per camper. All requests for refunds must be submitted in writing within 30 days of the cancellation. Allow a few weeks for our office to process refunds.

The Camp Director reserves the right to dismiss any camper whose conduct becomes in any way detrimental to the best interest of the other campers. No refunds will be given in these cases. Campers who become homesick and leave their camp session early are not eligible for refunds. The camp will not be responsible for expenses incurred in picking up the campers.

Special Note: Each camper will be examined for head lice upon arrival. If nits or lice are present, campers will be turned away with no refunds issued.

Camp Staff

The camp is staffed with a professional director, food service personnel, and trained counselors. A nurse or physician is on call during camp sessions.

Medication Policy

Over-the-counter medications brought to camp will not be accepted at check-in. Prescription medications should be in the original bottle with only the amount needed for the camper's length of stay at White Horse. All prescription bottles should come in a Ziploc bag with the camper's name written clearly on it.

Security and Phone Information

We are fully aware of our great responsibility in the care of your child. In case of an emergency, you will be notified immediately. Out of consideration for other campers and planned activities, incoming calls are not allowed except in case of emergency. Should campers need to contact parents; calls can be made through the camp office. White Horse requires that all adults staying on camp property to have an approved background check on file with our office. Visitors must call ahead to make an appointment for their visit with our office.

Adults and Sponsors

The fee for sponsors is \$129.00, but one sponsor can come free with every 10 paid campers. Because sponsor housing is extremely limited, only one sponsor is allowed for every 10 campers. Please call the registration office to see if extra sponsor spaces are available for groups traveling long distances. Adult sponsors must have a background check approved by the Registration Office. All sponsors must be at least 18 years of age or older. Sponsors will be housed in separate bunk rooms from their campers.
